

SAMPLE BEOUEST LANGUAGE

The Sisters of Charity of the Blessed Virgin Mary gratefully accepts outright gifts, gifts by bequest in a will, or gifts through a trust. If you are considering making a bequest to the BVM Sisters, we encourage you to refer to the sample language below. You may state your bequest in terms of a specific dollar amount, percentage of your estate, percentage of residue of your estate, or contingent bequest. This language is not intended as legal or tax advice. Please consult with your own attorney and advisors prior to finalizing any bequest or other estate plans.

Fixed Dollar Amount

"I/We give, devise, and bequeath the sum of ____ dollars (\$___) to Sisters of Charity of the Blessed Virgin Mary, a non-profit organization in Dubuque, Iowa, to be used for the mission and ministry of the Sisters of Charity of the Blessed Virgin Mary in accordance with its charitable purposes."

Percentage of Estate

"I/We give, devise, and bequeath ____ percent (___%) of my/our total estate to Sisters of Charity of the Blessed Virgin Mary, a non-profit organization in Dubuque, Iowa, to be used for the mission and ministry of the Sisters of Charity of the Blessed Virgin Mary in accordance with its charitable purposes."

Residue of Estate

"I/We give, devise, and bequeath all of the rest, residue, and remainder (or ____% of the residue) of my/our total estate to Sisters of Charity of the Blessed Virgin Mary, a non-profit organization in Dubuque, Iowa, for the mission and ministry of the Sisters of Charity of the Blessed Virgin Mary in accordance with its charitable purposes."

Contingent

"If (primary beneficiary) does not survive me/us, then I/we give, devise, and bequeath all of the rest, residue, and remainder (or ____% of the residue) of my/our total estate to Sisters of Charity of the Blessed Virgin Mary, a non-profit organization in Dubuque, Iowa, for the mission and ministry of the Sisters of Charity of the Blessed Virgin Mary in accordance with its charitable purposes."
